Rosehill Avenue Bridge Rehabilitation over TTC Yonge Subway Line

Contract #:13SE-11S Expected Start Date: September 19, 2016 Expected End Date: December 23, 2016 (weather permitting)

*Timeline is subject to change.

The City of Toronto is rehabilitating the Rosehill Avenue Bridge over the TTC Yonge Subway Line. This work will ensure that the bridge meets today's standards and remains in a state of good repair for future use. The project is part of the Council-approved 2016 Capital Works Program.

WORK DETAILS

At the beginning of construction, the City's contractor will move equipment on-site and prepare the work area before construction begins including marking utilities. The project will involve the:

- Partial removal and rehabilitation of the concrete bridge deck;
- Complete removal and replacement of the sidewalk, asphalt riding surface, and concrete road base;
- Localized concrete repairs;
- Installation of two valves on the existing watermain;
- Replacement of watermain on the bridge between the valves;
- Removal and replacement of utilities;
- Removal and replacement of the expansion joint; and,
- Other related repairs

The work will be completed in three stages; details are provided below.

WHAT TO EXPECT DURING CONSTRUCTION

- You may experience dust, noise and other inconveniences. The City will make efforts to reduce impacts. We appreciate your patience.
- There may be a necessity of night work for a short periods of time when staff install the valves on the watermain. This depends on the outcome of a water shutdown impact analysis.



Work Hours: Work will take place from 7:00 a.m. to 7:00 p.m., Monday to Friday. Extended hours and weekend work may be required in order to complete the construction on schedule.

Construction Notice

.	Road and Sidewalk Access: In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the construction work area.
	Stage 1 will be carried out with traffic reduced to a single one-way only lane for westbound drivers. Pedestrians will be restricted to the north sidewalk.
	Stage 2 will be carried out with traffic reduced to a single one-way only lane for westbound drivers. Pedestrians will be restricted to the south sidewalk.
	Stage 3 will be carried out with traffic restored in both ways. Pedestrians will be restricted to the south sidewalk.
	Drivers travelling eastbound will have to use Pleasant Boulevard and Acova Avenue for Stages 1 and 2.
	Water Service Disruptions: From time-to-time, the water supply to your property will be shut-off to complete construction; the contractor will provide at least 48-hour advance notice. The shut-off time will be kept as minimum as possible and will not exceed 6 hours in a single event. Throughout the work, it is recommended that you temporarily disconnect any water treatment systems (i.e. softeners or filters), water-cooled air conditioners or similar plumbing fixtures. Automatic lawn sprinkler systems may also be affected, therefore, you may need to water manually. In the event you did not receive advanced notice, an <i>emergency water shut off</i> could have been necessary.
8	Traffic Management : Efforts have been made to manage traffic in the area for the safety of workers, road users and residents. Some of these efforts include adding Local Access signs, revising traffic signal times. Road users should expect delays and increased traffic on nearby main and side streets.
	Due to the limited width of the bridge, for stages 1 and 2, there will only be one sidewalk and lane of westbound traffic on Rosehill Avenue, from Avoca Avenue to Yonge Street. Eastbound traffic should take Pleasant Boulevard and Acova Avenue for stages 1 and 2. For stage 3, there will be traffic lanes available for both eastbound and westbound traffic, but only south sidewalk will be available for pedestrian on Rosehill Avenue from Avoca to Yonge Street.
	Detour signage will placed to help road users navigate around one-way only zones during all stages. One-way traffic is required to safely manage all pedestrian and vehicular traffic passing through the work zone.
	Advance warning signs will be posted in the area to advise the public on traffic restrictions, lane closures, and pedestrian crossings.
	Access to the residences and businesses will be maintained during construction.
	Restoration: The construction work area will be restored with sod and/or asphalt where required. Interlocking bricks, flagstone on a granular base, or other similar features that are removed during construction will be replaced.
