DESIGN & CONSTRUCTION

06-074 The Board approved a staff memorandum dated June 15, 2006 recommending the

expenditure of \$26,969.45 (Provincial Sales Tax, Federal Goods & Services Tax, License fee and transfer fee all inclusive) to provide for the purchase of one vehicle set out in the recommendation from the dealership Marigold Ford Lincoln Ltd. located at 1120 Dundas

Street East, Whitby.

Carpark 43-C1 will be painted in budget year 2007 and sufficient funds of \$225,000.00 will be included in the 2007 Operating Budget.
- The Board approved a staff memorandum dated May 18, 2006 recommending that the construction contract for Carpark Nos. 15, 26 and 43-C1 Stair Floor Coatings and Tiling be awarded to Across Canada Construction for the sum total amount of \$398,000.00 plus GST.

- The President verbally advised the Board of several upcoming construction tender closings that will require Board review/approval prior to the next regularly scheduled meeting on July 18th in order to expedite construction commencement. The Board approved to schedule an additional Board meeting on Friday, June 30th at 12:00 noon (TPA Offices 2nd Floor) to deal with these specific construction related items.
- The President verbally advised the Board of the TTC's decision to purchase new revenue control equipment at the existing TTC lots and the TTC's request that Toronto Parking Authority technical personnel not be allowed to make any necessary repairs to the equipment as needed. The Board agreed that this request would hinder the TPA's ability to properly operate the carparks, resulting in vehicle lineups, etc. due to equipment malfunctions. The Board approved that Toronto Parking Authority staff advise the Toronto Transit Commission, in writing, of its decision to consider not renewing its present arrangement with the TTC.
