10-080 The Board confirmed the minutes of the June 15, 2010 meeting.

### FINANCE & ADMINISTRATION

10-081 The Board received, for information only, a list of cheques issued and shown as Annex A to the Agenda (vouchers 48813 - 49324 and voucher 400036).

The Board approved a staff memorandum dated June 23, 2010 recommending revisions to Policy Resolution 5-7 – "Approval of Disbursements, Calling of Tenders and Quotations". Revisions to the policy are in regards to the acquisition and review of banking and insurance services.

# **DESIGN & CONSTRUCTION**

The Board approved a staff memorandum dated June 17, 2010 recommending that the construction contract for the Parking Garage No. 26 (33 Queen Street East) and Carpark No. 111 (74 Clinton Street) – 2010 Painting Program be awarded to Across Canada Construction for the sum total amount of \$197,000 plus HST.

## PARKING OPERATIONS - OFF-STREET

10-090 The Board approved a staff memorandum dated June 23, 2010 recommending the following parking rates for implementation for the 16-space surface carpark located at the rear of 1695 Dufferin Street:

- 1) \$1.00 per half hour;
- 2) \$7.00 maximum, from 07:00 and 18:00; and,
- 3) \$4.00 maximum from 18:00 to 07:00.

10-091 The Board approved a staff memorandum dated June 23, 2010 recommending the following parking rates for implementation for Carpark No. 249 located at 1670 Bayview Avenue:

- 1) \$1.00 per half hour;
- 2) \$10.00 maximum, Monday to Friday from 07:00 and 18:00;
- 3) \$6.00 maximum from 07:00 to 07:00 Saturdays, Sundays and Holidays; and,
- 4) \$5.00 maximum evenings from 18:00 to 07:00 Monday to Friday.

10-092 The Board received, with amendment, a staff memorandum dated June 23, 2010 regarding the following parking rates for implementation at the Evergreen Brickworks:

- 1) \$1.00 per half-hour; and,
- 2) \$6.00 maximum per 12 hours.

On motion by Director Carter, seconded by Director Birchall, the Board requested that staff's recommendation be amended by replacing the word "approve" with "be advised" so that staff's recommendation shall read:

"That the Board of Directors of the Toronto Parking Authority be advised of the following parking rates for implementation at the Evergreen Brickworks:

- 1) \$1.00 per half-hour; and,
- 2) \$6.00 maximum per 12 hours."

Motion carried.
