3.0 PARKING OPERATIONS

- 3.1 Staff memorandum dated December 13, 2011 recommending the following rate changes for implementation at the following municipal carparks effective January 3, 2012:
 - 1) Municipal Carpark No. 402 10 Empress Avenue:
 - > Day maximum rate to increase from \$9.00 to \$12.00
 - Evening maximum rate to increase from \$5.00 to \$6.00; and,
 - Reduce the monthly permit quota from 25 to 0.
 - 2) Municipal Carpark No. 400 10 Kingsdale Avenue:
 - ▶ Half-hour rate increased from \$1.00 to \$1.25; and,
 - All day rate increased from \$8.00 to \$10.00
 - 3) Municipal Carpark No. 410 180 Beecroft Road:
 - Increase the monthly permit rate at Carpark No. 410 from \$100 to \$125 and establish a quota of 25 permits.
