04-037 The Board approved a staff memorandum dated March 3, 2004 recommending that:

 - (3) Increase the event rate from \$20.00 to \$25.00 at 45 Bay Street Municipal Carpark 32 (effective April 5, 2004);
 - (4) Increase the day maximum rate from \$8.00 to \$8.50 at 323 Richmond Street East Municipal Carpark 125;
 - (5) Increase the half-hour rate from \$0.50 to \$0.75 at Municipal Carparks 500, 501, 502, 503 and 504 (the Kingsway lots);
 - (6) Increase the monthly rates in accordance with the schedule below effective June 1, 2004; and,

PARKING OPERATIONS - ON-STREET

04-043

The Board approved a staff memorandum dated March 18, 2004 recommending an adjustment to the on-street rates and hours of operation in the Central Area be implemented and further request that City Council take the necessary steps to implement the following measures adopted:

- (1) Establish a new on-street charging zone, Zone AA, with a rate of \$3.00 per hour, as indicated on the "Proposed On-Street Rate Zones" map 2;
- (2) Extend the boundary of the current \$2.00 on-street Zone A to the east and northwest, as indicated on the "Proposed On-Street Rate Zones" map 2;
- (3) Reduce the hours of the chargeable on-street parking at the extended zone meters from 03:00 to 23:59, with free parking allowed at other times; and,
- (4) Create a new enforcement zone covering the \$2.00 and \$3.00 meters with a voluntary payment / set fine of \$20.00 and \$25.00 respectively.

Board approval was subject to the amendment of extending the Zone A boundary as indicated on the "Proposed On-Street Rate Zones" map 2 to include the area along Church Street north of Wellesley Street West to Bloor Street north.
