11-017 The Board approved a staff memorandum dated January 26, 2011 recommending that the Toronto Parking Authority continue to support the Toronto Association of Business Improvement Areas (TABIA) for the 2010 Citywide Campaign with a contribution of \$50,000.

11-018 The Board approved a staff memorandum dated February 17, 2011 recommending a \$50,000 contribution to the City of Toronto's 2010 Trees Across Toronto Planting Program.

11-019 The Board approved a staff memorandum dated February 17, 2011 recommending an expenditure in the amount of \$31,870 plus applicable taxes to LITGO System to purchase the Milestone XProtect IP Camera upgrade with 238 licenses.

## **DESIGN & CONSTRUCTION**

- 11-020 The Board approved a staff memorandum dated February 9, 2011 recommending that the consulting services contract for the Proposed Electrical Lighting System Upgrade for Carpark No. 42 91 Via Italia and Carpark No. 125 323 Richmond Street East be awarded to LKM Division of SNC Lavalin Inc. for the sum total amount of \$38,600 plus HST.
- 11-021 The Board approved a staff memorandum dated February 16, 2011 recommending that staff be authorized to:
  - approve and enter into a Construction License Agreement with HPT IHC Canada Corporation ("HPT"), the registered owner of the lands municipally known as 1 Bedford Road and/or Lanterra Developments Limited, and a Maintenance Agreement with the registered owner of the 1 Bedford Road lands, the City of Toronto, and HPT relating to the construction and maintenance of certain improvements to the pedestrian walkway leading to Municipal Carpark 58, substantially under the terms and conditions as outlined in staff's report and detailed in Appendix A; and,
  - 2) approve all necessary documentation including all necessary undertakings.

# PARKING OPERATIONS - OFF-STREET

- The Board approved a staff memorandum dated February 17, 2011 recommending that the TPA establish residential parking permits in municipal carparks 125, 126 and 510 as listed below. The permits will allow use from 16:00 until 08:00 the following day from Monday night through 08:00 Friday morning and use for the period from 16:00 Friday night until 08:00 Monday morning. The permit will be established as follows:
  - 1. Carpark No. 125 (323 Richmond Street East) at a rate of \$80.00;
  - 2. Carpark No. 126 (13A Parliament Street) at a rate of \$50.00, with the regular permit rate being increased from \$90.00 to \$100.00 effective May 2011; and,
  - 3. Carpark No. 510 (3239 Lakeshore Blvd.) at a rate of \$40.00.

On motion by Director Carter, seconded by Director Sinanan, the Board recessed the public session of the meeting to consider the following confidential report in closed session with specific reference made to the reasons cited under both the City of Toronto Act for closed meetings and the Toronto Parking Authority's Policy Resolution 1-1 "Meetings and Minutes Open to the Public".
