11-122 The Board confirmed the minutes of the July 26, 2011 meeting.

11-123 The Board confirmed the minutes of the August 2, 2011 special in-camera meeting.

 - 2) the decommissioning of Vehicle No. A-54 2002 GMC Safari Van, Vehicle No. A-57 1996 Ford Aerostar Van and Vehicle No. A-60 2001 GMC Safari Van. These vehicles are to be sold at City of Toronto auction at a later date this year.
- 11-130 The Board approved a staff memorandum dated September 15, 2011 recommending:
 - the expenditure of \$23,305.12 (taxes included) for the purchase of one (1) 2012 Dodge Ram 2WD regular cab pick-up truck from the dealership Toronto Chrysler; and,
 - 2) the decommissioning of a 2000 GMC S-15 pickup. This vehicle is to be sold at auction at a later date.
- 11-131 The Board approved a staff memorandum dated September 12, 2011 recommending that a three (3) year contract extension for wireless telecommunications services be awarded to Bell Mobility effective September 22, 2011 through to March 21, 2014.
- The Board approved a staff memorandum dated September 20, 2011 recommending that the 'Five-Year Plan on a Page' for the Toronto Parking Authority be adopted and the release of the accompanying document entitled "Strategic Outlook Enabling Mobility for the Next 21 Years".

DESIGN & CONSTRUCTION

- The Board approved a staff memorandum dated September 12, 2011 recommending that the Electrical Lighting System Upgrade contract for Municipal Carpark Nos. 42 and 125 be awarded to Rumble Electric Co. Ltd. for the amount of \$265,486.28 and an additional amount of \$24,513.72 as contingency allowance, being the sum total amount of \$290,000.00 plus HST.
- 11-134 The Board approved a staff memorandum dated September 12, 2011 recommending that the contract for the Construction of Municipal Carpark No. 248 at 136 Broadview Avenue be awarded to Melrose Paving Company Ltd. for the amount of \$272,893.00 plus \$27,107.00 as contingency allowance, being the sum total amount of \$300,000 plus HST.

- 11-135 The Board approved a staff memorandum recommending that staff:
 - develop a set of design standards for TPA surface carparks in accordance with the following principles:
 - the application of a palette of materials applied consistently, and which recognize different contexts;
 - ii) create and utilize a simple, sophisticated and elegant series of approaches that can be applied in the different contexts; and,
 - iii) provide landscaping which considers all seasons for appearance;
 - 2) select a carpark where the design principles and their application have not been successful and undertake retrofits;
 - a) explore the feasibility of engaging students in a landscape architecture program to participate in a design exercise and/or undertake a Design Competition for a parking lot as both a marketing and design demonstration opportunity;
 - 4) ensure that the evaluation criteria in proposal calls for the design consultants includes high quality design capability; and,
 - 5) report the results of the four recommendations above to an upcoming meeting of the Greening Committee.

DEVELOPMENT & MARKETING

- 11-136 The Board approved a staff memorandum dated September 20, 2011 recommending:
 - the selection of Endeavour Marketing as the successful proponent of the Advertising Agency Request for Proposal; and,
 - 2) an agency retainer of \$72,000 for the 2011/2012 Marketing period.
