DESIGN & CONSTRUCTION

The Board approved a staff memorandum dated June 12, 2012 recommending that the Prime Consultant Services Contract for the Proposed New Delivery and Storage Facilities at 305 Rockcliffe Blvd. be awarded to Our Cool Blue Architects (OCBA) for the amount of \$20,000.00 plus \$1,100.00 for disbursements and an additional amount of \$3,000.00 as contingency allowance; being the sum total amount of \$25,000.00 plus HST.

PARKING OPERATIONS - OFF-STREET

 - > \$1.00 per Half Hour;
 - > \$8.00 Day Maximum (7:00 am 7:00 am);
 - > Event Rate to be determined on an event by event basis
 - ➤ \$120.00 Monthly Rate (monthly rate at Carpark 263 only)

The aforementioned cash rates are to be effective upon opening.

PARKING OPERATIONS - ON-STREET

1) Increase the basic hour rate in the Zone AA, A, and B rate zones so the following rates apply:

that staff of the Toronto Parking Authority report back to the July 24, 2012 meeting of the Toronto Parking Authority with respect to the creation of a \$2.00 zone.
