PARKING OPERATIONS

- a) Machine Refurbishment Program (\$295 per unit / \$914,500 total);
- b) 3G Modem, Emulation Board and Antenna Replacement/Upgrade (\$995 per unit / \$3,084,500 total);
- c) NEO Web Access Management System (\$161 per unit / \$499,100 total);
- d) Fast Track Development White List (\$113 per unit / \$350,300 total); and
- e) Financial Reconciliation System (\$122 per unit / \$378,200 total).

On motion by Councillor Filion, seconded by Vice Chair Kozorys-Smith, the Board deferred staff's report for one month in order to allow staff to prepare a comprehensive presentation on issues related to pay and display machines. Motion carried.
