A meeting of the Board of Directors of the Toronto Parking Authority was held at Toronto Parking Authority Offices, 33 Queen Street East, 2<sup>nd</sup> Floor Boardroom at 9:30 a.m. on Thursday, July 28, 2016.

16-101 The Board confirmed the minutes of the June 23, 2016 meeting.

## FINANCE & ADMINISTRATION

The Board received, for information only, a list of cheques issued and shown as Annex A to the July 28, 2016 Agenda (vouchers 71881 – 72187 and 400107).

Board Chair Tziretas declared a conflict of interest with respect to Chq #81793.

### **DESIGN & CONSTRUCTION**

The Board approved a staff memorandum dated July 15, 2016 recommending that the Architectural Services Contract for the Proposed Signature Series Program at Carpark No. 52 – 40 York Street University Entrance and Stairwells be awarded to Oleson Worland Architects for a fixed average percentage fee of 12% of the final construction costs plus HST (Award not to exceed \$165,000.00 plus HST).

Director Leon noted that the cost information noted on page 4 (Table line items #1 and #2) were reversed. The Board requested that staff's report be updated to reflect the correction.

The Board approved a staff memorandum dated July 21, 2016 recommending that the contract for the supply and installation of roof security railing upgrade at various locations for Municipal Carpark 68 be awarded to Pro-Door & Dock Systems for the amount of \$48,000.00 plus \$5,000.00 as contingency allowance, being the sum total amount of \$53,000.00 plus HST.

For the record, it is noted that Director Leon declared a Conflict of Interest with respect to Minute #16-106.

- The Board approved a staff memorandum dated July 20, 2016 recommending that the construction contract for the 2016 Greening, Repaving and Lighting Upgrade of Carpark No. 78 at 35 Erindale Avenue be awarded to Melrose Paving Co. Ltd. for the amount of \$218,942.00 plus \$11,058.00 as contingency allowance, being the sum total amount of \$230,000.00 plus HST.
- The Board approved a staff memorandum dated July 20, 2016 recommending that the construction contract for the 2016 Surface Carpark Paving Program be awarded to Melrose Paving Co. Ltd. for the amount of \$1,114,258.45 plus \$25,741.55 as contingency allowance, being the sum total amount of \$1,140,000.00 plus HST.

## PARKING OPERATIONS

The Board approved a staff memorandum dated July 27, 2016 recommending the implementation of off-street facility rate changes as noted in Schedule A of staff's report, and listed as follows:

#### Daily Rates:

- 1) Controlled Facilities (Schedule AC) for implementation on Tuesday, September 6, 2016;
- 2) Uncontrolled Facilities (Schedule AU) for implementation commencing on Monday, September 19, 2016, with the exception of:
  - Carparks 51, 85, 93, 144, 2015, 231 for implementation on Monday, August 15, 2016; and,

### Monthly Rates:

- 1) Controlled Facilities (Schedule AC) for implementation on October 1, 2016; and,
- 2) Uncontrolled Facilities (Schedule AU) upon implementation of the new monthly permit system.

### **DEVELOPMENT & MARKETING**

- The Board approved a staff memorandum dated July 21, 2016 recommending the implementation of two murals at Municipal Carpark 179 located at 653 Gerrard Street East, for an amount not to exceed \$20,000.
- The Board ratified the results of a Poll of Directors conducted on July 10, 2016, which approved the decision of the Board's Real Estate, Development & Business Opportunities Advisory Committee that a letter be drafted from the TPA's Board Chair to the Mayor and Members of City Council for inclusion on the July 12, 2016 City Council Supplemental Agenda as a communication item for Executive Committee report (EX16.4).
